CONSIGNMENT AGREEMENT

The Ukrainian-American Archives and Museum (UAAM) sponsors gallery programs to sell the artwork of Ukrainian artists or art of Ukrainian themes and style to preserve the heritage of Ukrainian Americans.

As Owner of artwork, you warrant that you have unencumbered title to all art objects created by the artist(s) for consignment at the UAAM.

The Owner shall provide all information and documents concerning the artist and art objects as may be reasonably requested by UAAM.

As Owner, I agree to consign sale/exhibition will run from **DATE** _____ **TO** _____ (**DATE END**)

Once work has been accepted it cannot be removed for the duration of the exhibition.

Sale Price. Prices for art objects consigned hereunder are set forth in the price information provided by the Owner.

Records. UAAM shall keep proper records of transactions regarding the Owner's work and such records shall be available for the Owner's reasonable inspection during regular business hours.

Publication Rights. The Owner reserves all rights of reproduction of exhibition work, provided that the UAAM may publish photographs of all such work for promotional and/or educational purposes as it may deem appropriate.

Liability. UAAM is acting solely as a representative of the Owner, and neither it nor its trustees, officers, directors, employees, agents, members shall be liable for loss or damage to works of art on the premises or in transit due to fire, theft, negligence, or any other cause. UAAM does not have insurance coverage. The artist may have insurance as it deems appropriate but shall have no obligation to do so.

Commission. UAAM shall receive a commission of 35% of the sale price, regardless of other gallery affiliations.

Payment on all sales shall be made to the Owner within thirty (30) days after the close of the exhibit. Payment to The Owner for works sold on the UAAM Installment Sales Plan shall be made no later than thirty days after work is paid in full.

Return of Art Objects. Art objects submitted for sale will be picked up by the Owner/Agent after the close of the exhibition on _____. If art objects are not picked up by the thirty-first (31st) day following the close of the exhibit, UAAM reserves the right to dispose of them and if they are sold the UAAM shall retain all proceeds.

Binding Effect, Modification. The rights and obligation of the UAAM and the Owner shall be binding to the benefit of their respective heirs, representatives, successors, and assigns. Any change in this agreement must be in writing.
